Three Colleges listed below, have submitted their application for recognition as Research Centres of this University:-

1. KMEA Engineering College, Aluva
2. Sree Narayana Institute of Technology, Adoor
3. Rajadhani Institute of Engineering & Technology, Attingal

As per para 1.3 of the guidelines for recognizing Places of Research under this University communicated vide paper read as (1) above, the Standing Committee of the Syndicate on Academics and Research shall constitute a committee for inspection of the Institution to verify the facilities and submit recommendations based on facilities available for conducting research programs. As per para 1.4 - considering the recommendation of the committee, the Vice Chancellor shall make appropriate recommendation to the Standing Committee of the Syndicate on Academics and Research for further action. As per para 1.5, the Syndicate shall be the authority to declare an engineering college as a Place of Research.

As prescribed in the guidelines mentioned above, the Standing Committee of the Syndicate on Academics and Research had constituted a Committee for inspecting Institutions listed above who have applied for recognition as Places of Research of the University. The Committee had visited applicant Colleges and had submitted the Inspection Report for taking further action in this regard. Based on findings in Reports mentioned above, the Committee had recommended for granting all three colleges mentioned above the status of 'Place of Research' under APJ Abdul Kalam Technological University.

Considering the same, Hon.Vice-Chancellor had recommended for granting all three colleges mentioned above the status of 'Place of Research' under APJ Abdul Kalam Technological University and had ordered to place the matter before the Standing Committee of the Syndicate on Academics and Research for recommendations and to place further the matter before the Syndicate. The Standing Committee of the Syndicate on Academics and Research considered the same and had recommended to grant the status of 'Places of Research' under APJ Abdul Kalam Technological University to all three Colleges listed above.
